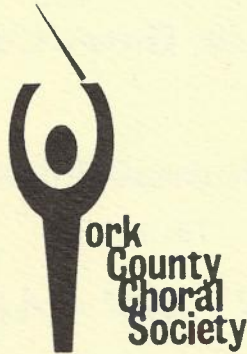

The purpose of the YCCS is to perform choral masterpieces with the proper instrumentation. The work of the society is possible only by financial support of patrons and ticket sales. All money is used for the production of concerts only — orchestra, soloists, printing, and postage are the largest expenses. Our next performance is Sunday, April 5, 1987 at 4:00 p.m. at Byrnes Auditorium, Winthrop College. The YCCS will be performing Mozart's *Vesperae Solemnes De Confessore*, K. 339; *Ave Verum Corpus*, K. 618; and Schubert's *Mass in G Major*, D. 167 — all with full orchestra accompaniment. Ms. DeVera Thomas, soprano, will perform *Exultate Jubilate* by Mozart. Dr. David Lowry, co-founder and conductor of YCCS, will be returning from his sabbatical and will direct the April performance. In his absence, Shirley Fishburne, Don Rogers, Mary Ann Helton, and Shelden Timmerman have prepared the singers for today's concert. Rehearsals for the April program begin February 5. Singers are admitted by simple audition, with rehearsals being held on Thursday evenings at Oakland Baptist Church, Rock Hill.
